2. Online Resources – Angela Turnick presented the following resources for consideration.

KYVL – Ms. Kennison gave an overview of what KYVL does.

IXL – Reading and Math – Angie Turnick stated that we reached out and got a quote. The quote is \$10,200 for one year. They provided a three-year quote as well. Angie Turnick stated that being committed for 3 years is a little concerning. Ms. Turnick stated that if we choose to do a one year subscription, that can be covered through Title money.

Renata Kennison – Is there a way to as a teacher, record my instruction and upload that to the classroom?

Adam Rader – Screen record on the Macbook works.

Angela Turnick – Bradie Bowen put together an intervention for students who are struggling or non-compliant. We need to set the expectation that students log in to the google meets. This is really the first 3-4 weeks of school that we follow this model and then evaluate to see if we need to make adjustments. Attendance right now is by daily participation and that is statewide, this could be where intervention process comes in as well. Will send out some guidelines for students while in google meet
